## Free Preschool 3 and 4 year old Program

### Central Preschool Registration

- Children must be between the ages of 3 and 4 years old by October 1st of the current calendar year and be a resident of Irvington, New Jersey in order to be eligible for enrollment
- Preschool registration is located at 97 Augusta Street, Irvington, NJ 07111

### Eligibility Requirements

- Children who turn 3 years old on or before October 1st
- Children who turn 4 years old on or before October 1st

### What Documents to Bring (Original and Copies):

- Birth Certificate/Passport/Visa/Green Card
- Immunization Record (Must include Tuberculin Test with result, if applicable)
- Physical/Examination-Health
- Current Proof (1) of Residency (PSE&G bill, Cable bill, Homeowners Tax Bill, Mortgage, current year or month-to-month lease) or Notarized Letter with Proof of Residency
- Custody Papers (If Applicable)

### Preschool Curriculum

The Irvington Public School's Office of Early Childhood is committed to maintaining a high quality preschool program. The preschool program follows the Creative Curriculum's educational approach to preschool teaching and learning. The Creative Curriculum is one of four state approved curricula which provides an opportunity for positive interaction, social/emotional competencies, constructive play and Teacher-Family interactions. The Creative Curriculum is a research-based curriculum provided in both English and Spanish, which supports Spanish speaking students. The curriculum is comprised of a comprehensive collection of daily practices and knowledge building learning experiences that promote intentional academic skills in early literacy, math, physical, cognitive and social/emotional development.

The curriculum supports students as they become independent, self-confident, inquisitive learners. The Creative Curriculum teaches students how to learn, not just in preschool, but throughout their lives. The curriculum allows scholars to learn at an individual pace and in ways that are best suited for them. The curriculum establishes a foundation that promotes good habits and attitudes in children that foster a positive sense of self as they progress through life.
